



Map of the services









Detention Centre Profile

<u>Busmatsi</u>

The Centre is located near Sofia and it is the largest detention facility for foreigners in Bulgaria. BRC Protection team strives to conduct regular visits to the center to assure adequate dialog between the management and the accommodated. The whole center is around 6000sqm big, including space for sport activities and service grounds. Two big buildings, one administrative, containing the medical cabinet, medical isolator, interview rooms and administration. The other one has 4 floors. On the ground floor, there is a canteen, on the 2nd and 3rd there are male compartments, and on the 1st - the family compartment. Bellow can be seen visual analysis of the main sectors of focus measured during the years. The overview is based on the analysis of all visit reports and on the number of times issue has been raised or resolved. Sector are scored from 1 to 10 where 1 is severe problem and 10 is desired result.


Lyubimets


Being the second active and largest center in the country, Lyubimets has a crucial role in the migration response in Bulgaria. The center is often used as an example on how other ones should look like and in deed when examining the accommodation and hygiene level in Lyubimets there is little to improve. However, the center is also notorious with its strict rules and BRC access is still not on the desired level. Bellow can be seen visual analysis of the main sectors of focus measured during the years. The overview is based on the analysis of all visit reports and on the number of times issue has been raised or resolved. Sector are scored from 1 to 10 where 1 is severe problem and 10 is desired result.



The Bulgarian Red Cross is the only organization operating in the detention centers that retained its regular visits and rights during the pandemic. For 2020, the protection team was able to maintain its position before the leadership of the centers and to support a significant number of migrants in need. A summary of the assistance provided shown in the infographic. is Prevention measures were kept in 2021, with less need for the BRC to intervene.
